



2022 F4 US Championship & FR Americas Entrant Checklist



Welcome to the F4 US Championship and FR Americas and for 2022! We are excited that you are going to join our series and we want to make things as straight forward as possible for you. Please follow the below checklist to assist you in completing the right forms the first time around. Following this checklist will help your season get off to a good start.

If you need to register a vehicle, the following form must be completed:

- ☐ 2022 F4FR Vehicle Registration

Note: A separate Vehicle Registration must be completed for each vehicle competing in the series. Backup cars must also be registered. Vehicle Registrations must be fully filled out to be accepted.

For a driver registering in the series, the following forms must be completed:

- ☐ 2022 F4FR Driver Application
Please submit a Racing/Competition Resume as well showing recent racing experience.
- ☐ A new "head shot" photo must be submitted to FRF4Registration@parellamotorsports.com.
- ☐ Appropriate Release and Waiver of Liability form (See below for instructions).
- ☐ SCCA Examination Form (Medical)
- ☐ SCCA Applicant's Medical History Form
If the applicant held a 2021 F4 or FR Competition License, the Medical forms may be valid for 2022, depending on the applicant's age.
- ☐ Prize Money Authorization Form – may be completed by the entrant if the driver is different from the entrant.

Plus one of the following for the Prize Money Recipient:

- ☐ US Citizens – IRS Form W9
- ☐ Non-US Citizens – IRS Form W8-BEN

All Release Forms **must be printed in color and notarized** (or signed by a non-household SCCA member).

- ☐ **Adult** Release and Waiver of Liability (only those 18 and over) – Please ensure you select the proper form. If you are in a state other than California, you must submit form #1306, edition 09/2020. California residents must use the version with the Notary Public box (form #1306CANotary ed 09/2020). The properly completed, printed in color and notarized Adult Release document can be scanned and emailed. It must have the 2022 year at the top and your member number (if returning) on the Member Number line. *
 - ☐ **Minor** Release and Waiver of Liability form (those under 18) – Please ensure you select the proper form. If you are in a state other than California, you must submit form #1068, edition 09/2020. (2 pages) If you are in California, you must submit form #CA Notary1068, edition 09/2020. (2 pages) *
- All Minor Releases MUST BE MAILED and must arrive more than 7 days prior to an event.**

* The SCCA Digital Waiver can be completed in lieu of the printed paper forms.

For members of the crew, an Annual Credential should be issued. The following forms will be needed to issue crew credentials:

- ☐ 2022 FR/F4 Crew Application
 - ☐ A "head shot" photo must be submitted to FRF4Registration@parellamotorsports.com, unless a photo is on file with SCCA.
 - ☐ Appropriate Release and Waiver of Liability form (See above for instructions).
- Note:** Crew Credentials can be issued at the track if the applicant is over 18 years of age. Submission of applications in advance will minimize the wait in line at event Registration.

All forms can be emailed (preferred for better turnaround time).

For Adult Non-US Citizens, the Release and Waiver of Liability can be executed at your first event.
